C. SUPPLEMENTARY SPECIFICATIONS

ART. 2 DESCRIPTION:

The Event "Shortrally Monteberg" will be run over two different Special Stages fully on hard tarmac surface; SS Monteberg with distance of 8,10 KM and run four times and SS Busseboom with a distance of 8,44 KM and run three times (see attached draft itinerary). The total distance of the Event is 114,7 KM which includes 57,84 KM as competitive sections.

ART. 3 ENTRIES:

Entries will only be accepted through our online system on www.monteberg.com

The online entry form should be send fully and correctly filled and signed to the addrress below before 30 april 2017 at 23.59 uur:

SuperStage VZW, Vlamingstraat 4, B 8560 WEVELGEM

The organisators state that only the competitor will be held responsible to send on his entry form.

Incomplete entry forms will not be accepted and will be seen as faulty.

Foreign Competitors need to be in possesion of a valid national license and authorisation of their ASN.

Maximum 150 crews will be accepted to start the Event.

Priority will always be given to the competitors who had paid their entry fee before the Administrative Checks.

From the moment the maximum number of allowed entries is reached a waiting list will be created. The complete list of the pre entered competitors will be send to the secretary of the VAS.

If the maximum competitors are not achieved, then competitors are still allowed to enter on the day of the Administraive Checks, but the entry fee will be raised by 20%.

The organiser had the right to refuse an entry of a competitor by a handing over a motivation letter to the Board of the Stewards.

ART. 4 ENTRY FEE, INSURANCE, START AUTHORISATION:

Entry fee:

The entry fee is 128,00 € and has to be paid to the organisation.

All event documentation such as roadbook, start numbers enz. are included in this fee.

Start Authorisation:

The Steward on duty will give a start authorisation to each crew who duly paid the insurance fee and the working cost to the federation (VAS VZW).

Insurance fee: 73,00€
Right of Participation to the federation: 12,00€
Participation to the Safety Costs: 12,00€

The total fee will so be 98€. This sum has to be paid in cash at the Administrative Check to the Steward on duty.

Competitors with a RACB license will have to pay an administrative fee to the federation recht of **60€** to be paid to the Steward on duty.

At the Administratrive Checks each team will be asked to pay 5 € for the safety marshals.

ART.5 ELIGIBLE CARS:

All participating cars should be conform to the technical and safety specifiactions of the VAS regulation. The participation cars should be conform to the prescriptions of the Traffic Code and so be in possesion of a valid conformity card and insurance card.

ART. 7 TIMECARD

First time card will be handed over at the Administrative Checks.

A new time card for the next section will be handed over at TC 1C - 3C - 5C SERVICE OUT.

The timecard of the last section needs to be handed over at TC7A Park Ferme IN.

ART. 8 OFFICIAL NOTICE BOARD:

The official notice board will be in the HQ at the meeting center "De Klaverhullle" Schoolstraat 12B in Wijtschate.

ART. 9 PUBLICITY:

The competitors should put all publicity, imposed by the organiser. In case of non respecting this rule a fine equal to the double of the entry fee will be applied.

The compulsory publicity has to be put on the locations imposed by the organisers from the technical scrutineering controle until the end of the Event.

ART. 10 RECONAISSANCE:

Recce is authorised from Saturday 7 april between 17.00 and 21.00 uur with standard cars without safety cages. Maximum 2 passes per competitor and will be controled by the organiser.

The organisers informs the competitors that the Traffic Regulation should be followed at any time, so also during the recce.

ART. 11 FINAL SCRUTINEERING:

The final scrutineering can be held at: "Garage Godrive", Mandestraat 4 te Kemmel.

ART. 12 PRICES AND TROPHIES:

The price-giving will take plave at 20h30 on the kiosk on the Sint Medarusplein located in the middle of the servicepark. Trophies will be handed over to the first three of each division and the winner of each class and first lady.

ART. 13 SUPPLEMENTARY PRESCIPTIONS:

This supplementary regulation is based on the standard VAS-rally.

All not included items will be covered through the VAS regulation and the national sportcode of the RACB.

Damage caused by a competitor to third parties or another competitor should be reported immediately to the organiser before, during or after the Event.

In case of an accident the competitor should have to contact the technical scrutineer to get his car checked before the next section.

This control will take place in the servicepark.

ART. 14 VARIA

- The servicepark will be accesible from 12h30 on Saturday 6 May 2017
- Registration at the entrace of the servicepark is compulsory and this will be located at TC Service IN close to Brouwerij Bartier in the "Wijtschatestraat". (See plan on our website) The organisation shall attribute a place in the servicepark according to the plan.
- Considering the risk of fire in the servicepark every individual service area has to be equipped with a controlled fire extinghuisher ABC of minimum 6 kilogram following norm EN 3-7. It means that every place where a car will be serviced should have a valid extinghuisher.
- Never it will be allowed to refuel the car in the servicepark. At all time refueling should have in the Refuel Zone, located in Mandestraat 4 in Kemmel (see road book 2.41 KM after service OUT.
- A competitor will be disqualified if he does not comply to one of the above rules.
- Teams who would like to service together in the servicepark should contact info@ypresrally.com, before 30 april.
- Trailors are not allowed in the servicepark. A special parking will be communicated later.
- Servicecars have to glue the SERVICE stickers behind the window.
- There is a maximum speed of 30 km/h in the servicezone.
- The road in the servicepark should remain free.
- Each team has to use compulsory a ground sheet. VAS standard regulation(Hfdst. 7 Art 16)
